1-Star USATT sanctioned table tennis tournament

Events: 9:30 start time. Gym opens at 8:15 for warmup. Giant round robin. Three phase round robin with Elite, A, B, C and D divisions. Preliminary round robin groups will be played to determine singles divisions. The top finisher in each round robin group will advance to the Elite group, second place finisher will advance to the A group, etc (all players play phases one and two). Second phase will feature two round robin groups in each division. In the final phase the top finisher from each round robin group will play a cross-over match against the other top finisher within their division to determine overall division winner. 7 to 8 matches per player. **Free pizza and drinks!!!**

Awards: Elite division..... 1 place-\$200..... 2nd place-\$100. A division..... 1st place \$75..... 2nd place \$50. All other categories will receive trophies for 1st and 2nd.

Entry Deadline: Entries must be received by 5pm Thursday, March 15th 2011. Entries will not be accepted without payment. **We guarantee the acceptance of the first 40 timely entries.**

Equipment: Butterfly 3 star orange 40mm balls will be used. Only USATT approved tables and nets will be used.

Rules: All USATT regulations apply, including dress code (absolutely no orange/red shirts or large decals allowed). Tournament committee reserves the right to modify format and prizes to accommodate the number of entries or cancel event and refund money in case of insufficient entries. No refunds after entry deadline. **Minors must be accompanied by an adult.**

Membership: Proof of USATT membership is required. Membership may be purchased along with tournament entry form. Adult membership \$49/year or \$130 for 3 years. Junior is \$20/year. Players who don't want to purchase a full membership may purchase a tournament pass for \$10. *** You may not purchase a tournament pass if you were previously a USATT member or have ever purchased a tournament pass.
